Update on the Arctic Council Project Support Instrument; version 14 October 2015

This PSI Report updates the previous Report¹ to the SAO Meeting in Whitehorse, Yukon, Canada March 4-5, 2015

Background

1. **PSI Mandate**²: The Arctic Council Project Support Instrument (PSI) is to focus on actions against pollution in the Arctic. The Instrument is a voluntary, non-exclusive mechanism for financing specific priority projects that have already been approved by the Arctic Council. The PSI Instrument may make use of a broad range of funding arrangements to include grants and revolving instruments.
2. **Response to Arctic Council Priorities**³: The PSI strengthens the Arctic Council and its work on environment protection including climate change (SLCP) and actions in support of the implementation of the Persistent Organic Pollutants (POP) and Heavy Metals Protocol on Long-Range Trans-boundary Air Pollution (LRTAP).
3. **PSI strategic work programming**: For the period 2014–2019, the PSI has tentatively allocated⁴ about 40 per cent for projects on hazardous waste management including POPs and pollution prevention. Budget allocation for mitigation of mercury is about 25 percent and 20 percent for AC projects dealing with clean production, energy efficiency, short-lived climate pollutants (SLCP) including black carbon and methane.
4. **Reporting**: The Arctic Council PSI Guidelines (§5.1)⁵ requires the Fund Manager (NEFCO) to semi-annually present to the SAOs a report on the activities pertaining to the PSI.

STATUS REPORT

5. On the 14th of September 2015, the Government of Norway, as Contributor, signed the Arctic Council PSI Agreement on Cooperation with the NEFCO as the Fund Manager.
6. The Russian Federation deposited the final tranche of EUR 5 million of its pledge of EUR 10 million on the 7th of April 2015. PSI Contributions, deposits, pledges, as of 30 April 2015, are summarised in Table 1 below.

7. Total funds used up to 30 April 2015 amounted to EUR 302 302.85. Approved allocations from the PSI, including decisions made at the Fourth Meeting of the PSI Committee on 13 October, amount to EUR 2.3 million. A total of EUR 10.2 million is thus available for further allocations.
8. Funding relevant decisions made by the PSI Committee at its 4th Meeting can be summarised as follows:
 - An allocation of up to EUR Four hundred thousand (EUR 400,000) for a feasibility study to assess a Russian Railways' project proposal to manage and destroy PCB⁶ wastes in the Russian Federation;
 - Encouragement to the Fund Manager to continue discussions with the Expert Group on Short Lived Climate Pollutants (EG SLCP) to develop an Expression of Interest to finance a project on "Mitigation of Black Carbon and Methane Emissions in the Russian Arctic Region";
 - Noting of the Fund Manager's continued discussions with Arctic Council's Working Group on Sustainable Development (SDWG/Expert Group) and the Expert Group on Indigenous Peoples Contaminant Action Program (IPCAP) to further develop an Expression of Interest to finance the project pertaining to "Clean Water Supply, Sewer and Renewable Energy in the Arctic Region";
 - Encouragement to the Fund Manager to continue discussions with the EG SLCP and project partners in the Russian Federation to further develop an Expression of interest or a Final investment Decision, as appropriate, to finance the project "Mitigation of Methane Emissions -- Syktyvkar Dyrnos Landfill Project, Russian Federation".
9. The PSI work since 2014 and the Work Plan for the period 2015-2016 is summarised in Table 2 below. The PSI is addressing approximately 30 projects with a total cost estimate of about EUR 58 million.

10. A working draft (Version 2015.09.09) of the PSI Manual has been prepared by the Fund Manager. The Manual is to undergo regular revisions. The PSI Manual is intended to provide members of the PSI Committee and the Arctic Council (AC), its permanent participants, AC bodies, observers and other possibly interested stakeholders and potential project proponents with a detailed guide on the workings of the PSI, including guidance on how to apply for funding and the criteria used for approving financing from the PSI. The PSI Manual is freely available at the Fund Manager NEFCO's website: http://www.nefco.org/financing/financing_instruments
11. A corresponding, user friendly, 2 paged "PSI Flyer" was published by the Fund Manager on 1.7.2015. The purpose of the Flyer is to provide simple and understandable information on the PSI to policy makers and the interested layman. 12. The Chair of the PSI Committee is elected on the basis of the alphabetical order of the Contributing Arctic Council (AC) States and rotated on a one year basis. In light of above, the 2015 Chairmanship of the PSI Committee, provided by Sweden, will be succeeded by the United States of America for 2016.

 - iii) welcome the deposit of the second tranche of the Russian Federation contribution, an amount of EUR 5 million, of its total pledge of EUR 10 million.

iv) note with appreciation the 2015 PSI Chairmanship provided by Mr. Ulrik Westman (Sweden) and welcome [•]ⁱ of the United States of America as the 2016 Chair of the PSI Committee.
